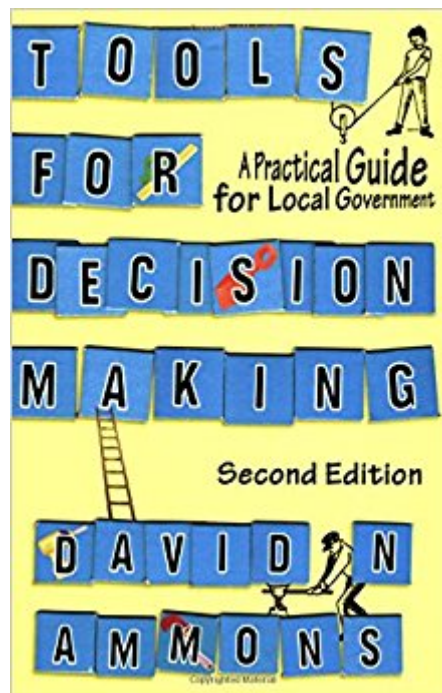

David N. Ammons is Albert Coates Professor of Public Administration and Government at the University of North Carolina at Chapel Hill. Among his other books on local government management are *Municipal Benchmarks: Assessing Local Performance and Establishing Community Standards* and *Leading Performance Management in Local Government*. Early in his career he served in various administrative capacities in four municipalities-- Fort Worth, Texas; Hurst, Texas; Phoenix, Arizona; and Oak Ridge, Tennessee. He consults with local governments on organizational and management concerns, including performance measurement and productivity

improvement.

The format of the book is problem solution based. I have never in my life had some of these analysis tools explained to me in such a simple manner. The problem is presented via a real life public administration problem and then using that issue the analysis is explained. Very useful and I am sure i will use the things that I have learned from the book in various positions in my future.

A good resource for anyone taking a graduate course in Statistics.

This book contained a lot of valuable information but was a little dry. If you are getting it as a reference guide, as I was, it is great. However, if you are looking for a recreational read, it may not be the best.

This is a useful little book that is designed to provide tools for decision making at the local government level. The Preface describes the focus of the book as "a guide to practical techniques of analysis for local government." The author, David Ammons, is a realist. He recognizes that politics can trump analysis, so that event use of these tools will not prevent politics from determining decisions. For instance, at the close of the book, he notes that "Local government decision makers must contend with multiple and often conflicting objectives." There is a nice table at the outset of the book, showing different analytical techniques available for local decision making. Throughout the book, a series of these are discussed in readable language. Among these? Demand analysis, PERT, performance standards, figuring interest rates and yields, cost-effectiveness analysis, analyzing survey data, benchmarking, and so on. All in all, a rather straightforward handbook. Much of the discussion is at only an introductory level, but that is not inappropriate given the book's purpose. On the other hand some of the discussion may be slow going for local officials. Bottom line: a useful little book.

This book is okay, the information contained in it is good. However, the same information can be found throughout the internet, without too much browsing.
