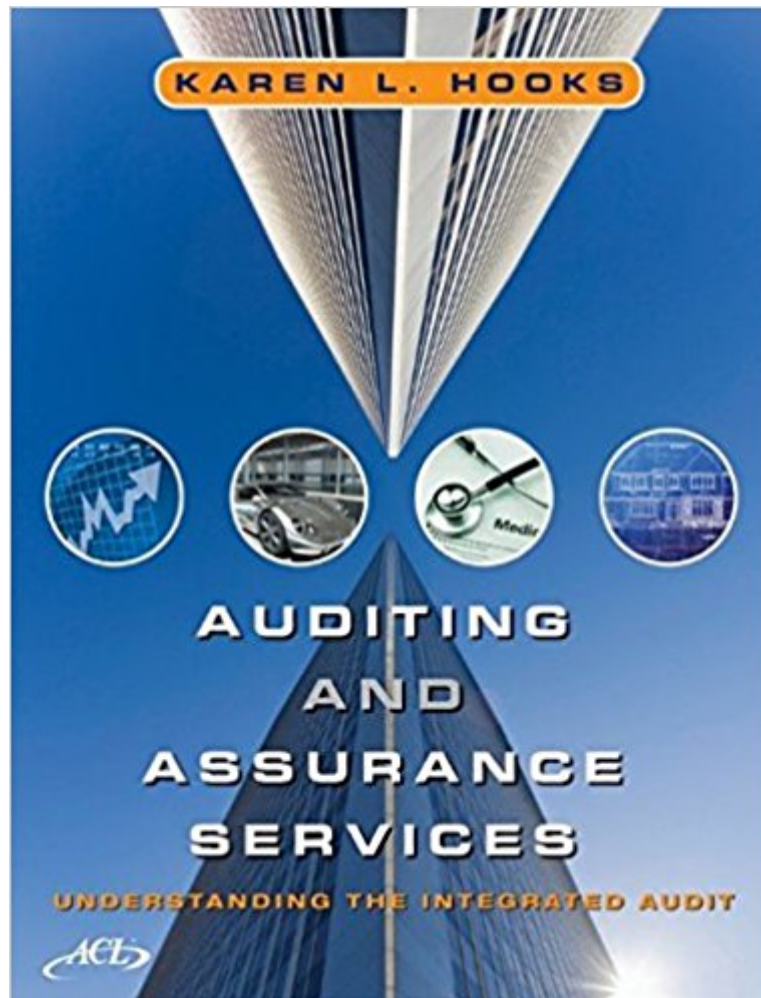

I am an adult student. If you are a professor looking for a textbook for an adult class, this isn't it. The book speaks to 18 year olds who've never held a job and it says the same thing over and over; i.e., still repeating the same thing in Chapter 6 as in Chapter 1. The questions at the end of the Chapter are trick questions, that is, a couple of answers might be right, but you have to pick the best one. Lastly, this book does not provide any hands-on auditing experience, such as a "faux" audit. It simply lectures AT you and that is not how I learn. It's akin to telling someone how to disassemble and reassemble an engine and going on and on about it, yet never letting the person actually do it! This makes for difficult reading and understanding, because after reading for awhile, there's a tendency to "tune out".

I have read other auditing books in the past as a professional consultant with auditing experience, and I can tell you, this book is absolutely terrible! It has no order, or construction. The chapters are long-winded, confusing, with even poor use of the english language. The examples in the book are not even relevant to most of the reading?? I have to use the book for one of my accounting classes and the professor has commented on various occasions that the book should never have been used for the class. He has even apologized...

It is very clear that FAU only requires this book because they're own professor wrote it. It is horribly written and not very conducive to learning. I left the class not learning a thing about auditing. The questions taken from her test bank are even worse. I spent more time figuring out what the question was trying to ask than forming an appropriate answer. If I could have given zero stars, I would have.
