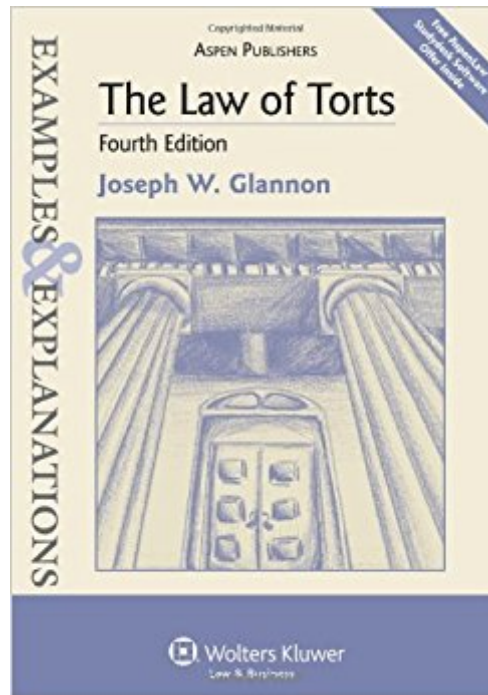

This book is the best supplement I used for any of my classes this past semester! Highly recommend using the book throughout the semester to reinforce what your professor teaches you. Being a night student, I found it very helpful to study this book during breaks at work more so than flash cards or lugging a casebook. Glannon is great! The E & E Civ Pro book by Glannon is equally as good, but it should be updated to include some of the new things that have come about since Iqbal and Twombly. It should be noted that not all the E & E books receive as much praise, but I would recommend this one to anyone in torts.

I'm finding my torts class difficult at times, so I'm glad to have this book for my text. It has a lot of examples to illustrate each concept, which is helping me grasp all the ideas pretty well. Also, the book is not nearly as expensive as a lot of textbooks, so I feel I'm getting my money's worth out of it.

As usual, the Glannon books do an excellent job of supplementing lectures and reading. This E&E covered the material similarly to how my professor did, making it a great study guide. However, it is no substitute for good notes and questions to professors. If you don't have at least a tenuous grasp of the material, this book isn't going to give you a miraculous understanding of torts. Bottom line: if you need some practice and/or slight clarification, you can't beat Glannon.

I found this book very easy and useful for review, but not as interesting to read as the Contracts E & E. This book has really great information and advice for exam taking, and I really liked the timed sample exams (with sample answers) in the back of the book. The other review books I have used just had short, issue-based hypos but this book had those as well as the longer exams. The only problem with the practice exams is that they include all of the topics in the book, and it is unlikely that you will have covered them all in one semester of torts. Even so, you can definitely work around it and this book helps you put all of what you've learned into context.

I bought this specifically to study for the Torts 2 final. I didn't find it as useful as I had hoped, but that's not as much a limitation of the book as it is a quirk of the class and the professor. I felt that some of the explanations could have used more detail and more technical references, as it was fairly colloquial in the explanations.

I started reading/practicing with this book the summer before my 1L year. Glannon's writing is easy to follow and he successfully conveys the black letter law in terms anyone can understand. I have

tried MANY other tort supplements and Glannon's E&E is by far superior. The hypos provided me with a competitive edge on test day -- (and some of them were actually funny!) Buy.

Gannon produced another extremely helpful book for first year law students. I aced my exam solely because of this E&E.

Great example of an E&E! This one is funny, personable, the writer is on the level with you. I used it the first half of the semester before transitioning to Siegel's, which is great also. This E&E really helped me get a handle on torts in the beginning though. Aced my midterm.
