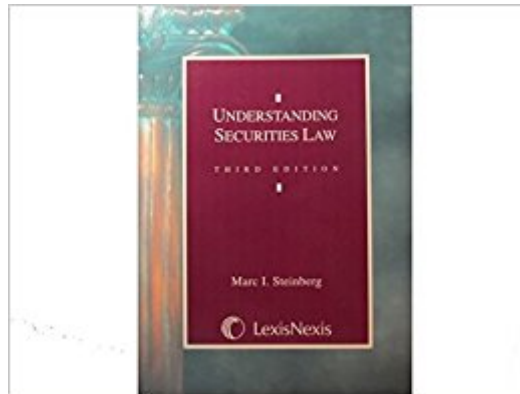

Securities Regulation is one of the hardest courses in law school, not least because it requires close reading of highly technical statutes. Unfortunately, there are relatively few well-done guides to

securities law. Steinberg's text is one of the best--if not the best. He combines detailed textual review of major concepts with extensive references to both primary and secondary sources. As such, practicing securities lawyers will also find it a useful source of precedents.

I used this book as a supplement in my Securities Regulation course. I had shopped around and looked at a few different supplements before purchasing this one. Steinberg's book was the clearest, had the best logical layout and did an excellent job of cutting out extraneous details. It was of great assistance in clarifying difficult concepts such as the 4(1 1/2) exemption. Overall a very useful supplement for students. I've also found the book a good quick reference guide for practitioners. Obviously given it's relatively short length it is no substitute for a treatise, but it is much easier to look at to get a general overview on a given issue and to guide you toward useful additional research.
