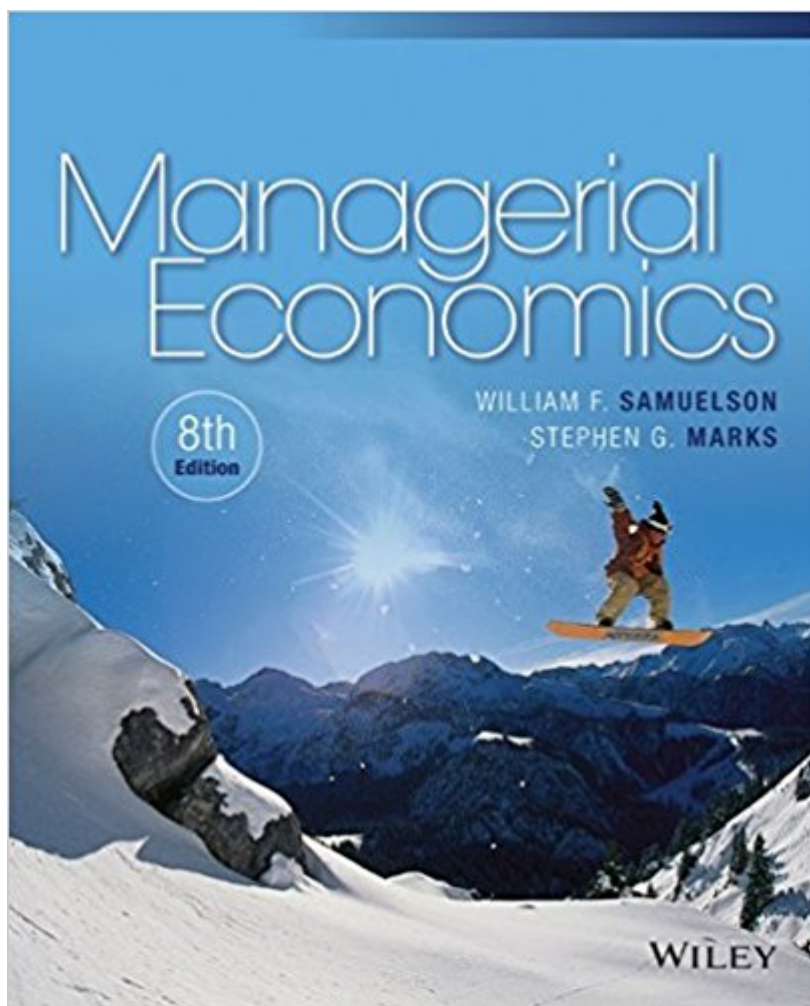

The authors really make it user friendly, especially the mathematical explanations, both algebraic and calculus. I also like how after a new concept was explained there was a sample problem to be done right there so the process was fresh in the readers mind; it has been a long time since I was in a math class so I found that extremely helpful. There are two things that I dislike about this text, one is that it has no glossary, but the definition of terms in the text makes up for that. They are clearly defined and not just in one chapter, if the term comes up again in a different scenario it is defined again. The other thing I didn't really like about the text was that it was a bit repetitive the beginning and end of each chapter making the text longer, the only perk to this is that each time it repeated itself it built upon the idea a bit building a better understanding.
