

Professor Rossi is great, but as others have warned in their reviews, the sound quality is terrible. I'm constantly adjusting the volume, turning it up to hear only then to have my ears blasted as the sound suddenly changes to full force once again. The lecture itself is good, but I wish the production was better. Also a bummer- each CD is one long track, so that can get cumbersome as well. (I have the CDs for criminal procedure from Sum and Substance and each CD has multiple tracks with different subjects so they're easy to refer back to if needed)

Can Rossi teach all of my law school classes? Voice and personality make a big difference with audiobooks. I found him engaging and easy to listen to for many hours without getting bored. This really was helpful both in preparing for class and while studying for the bar exam.

5 Stars for Rossi. If I could give a rating for audio quality, I would give it a 3. You get the occasional audio spike. I suggest setting your cd player to compress mode.

This product is an excellent supplement to a law school evidence course. I am currently a student at New York Law School, and I also work within a Municipal Court in New Jersey. This provides a great background of the rules of evidence, and more importantly when they do, and do not apply. It should be understood that this is an overview, and shouldn't be used as a substitute to what is being taught in actual evidence classes. Overall this is an informative and helpful review of the rule of evidence.

Rossi is good at explaining the concepts and some of the mechanics of the rules, and the Italian accent makes it entertaining. All the essential topics are there. He takes long pauses, though, and the CDs don't go into a ton of detail compared to what is in an Evidence course. Freer's Law School Legends Civil Procedure CDs set a high bar, so it is tough to compare.

I would recommend this audiobook for someone interested in a basic overview of the most common topics in Evidence law. As admitted by Rossi himself, the lecture is not intended to encompass all the topics nor any one topic in great depth. However, he does a very good job in covering the basics. In short, his lectures are a good starting point as supplemental material. He seems to do particularly well in setting a scenario and discussing the practical aspects of the applicable rule. Since each CD contains only one track approx 1 hr long, finding a specific topic on the disk is very inconvenient.
