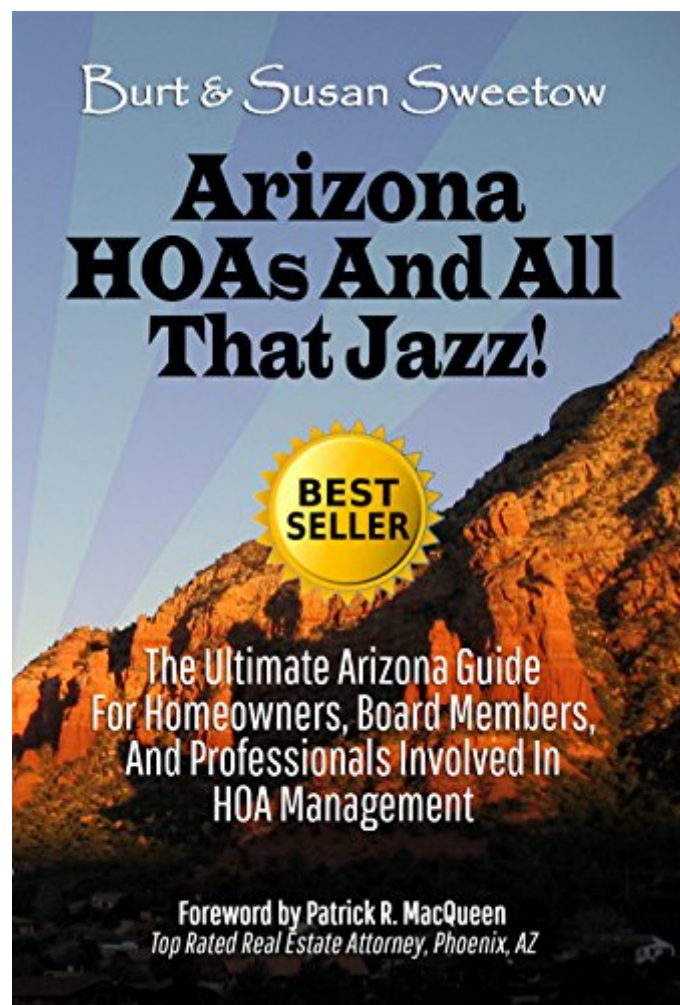

I have lived in a Home Owners Association for the last 40 years. Both in California and for the last 30 years in Arizona. I was president of a HOA in California. It was a matter of keeping the landscaping in hand. There is so much more to know about an HOA. The legalities of protecting homeowners is of the utmost importance. This compendium Arizona law is an HOA president's bible. You should not accept the job as president without studying this book, not only to protect your homeowners but also to protect you. This book is not Burt and Susan's opinion, it is the law of the state of Arizona.

While this is the first book I've come across specific to Arizona HOAs, it left me disappointed in that the majority of the book's content is dedicated to the reprinting of the State Statutes governing HOAs - the Arizona Condominium Act, the Arizona Planned Community Act and the Arizona Non-Profit Corporation Act all of which are readily available from multiple sources, at no charge, via online and print publications. The authors contributed an approximate thirty-six page thumbnail of information specific to the history of HOAs, HOA governing documents and the responsibilities of HOAs by both a board of directors and a contracted management company when hired. While this book could prove useful to new residents by providing a basic overview of Arizona HOAs, in my opinion, not enough detailed information is presented to brand the book as "The Ultimate Arizona Guide For Homeowners, Board Members, And Professionals Involved In HOA Management".

I have known and loved the Sweetows as friends and Realtors for 50 years. They sold us our home in an HOA in Scottsdale 17 years ago and they have been our go to resource for HOA questions and now we have their wonderful book to use as a necessary and convenient homeowners guide!
